.... The Nigeria Internet Group (NIG) is a not-for-profit, non-governmental organisation promoting Internet awareness and access in Nigeria.

Internet awareness became significant in Nigeria with the formation of NIG in 1995 and the group has turned out to be a national strategy for achieving full Internet connectivity.

NIG membership cuts across all the strata of the Nigerian Society who are stakeholders in the Internet business. These include NGOs, government and its agencies, the private sector, educational institutions as well as trade and professional organisations.

The membership (which are in three categories: Corporate, Individual and School chapter) is open to all. Intending members are required to fill the application form for admission into the membership obtainable from the NIG secretariat. This must be submitted with the payment of the membership registration fees as follows:
